

### Snowmobile Checklist

- \_\_\_ 1. Renter understands how to start and to stop the snowmobile.
- \_\_\_ 2. All lights are working properly and renter understands how to operate them.
- \_\_\_ 3. Renter has a valid driver's license issued by the State of \_\_\_\_\_ and be 18 years of age.
- \_\_\_ 4. Renter understands how to operate the throttle, brake and safety switches and will always check them before operating the snowmobile.
- \_\_\_ 5. Renter will not get on or off the snowmobile while the motor is running.
- \_\_\_ 6. Renter will not check track system, under the hood, skis, or any part of the snowmobile while it is running.
- \_\_\_ 7. Renter will not let any part of his/her body or clothing or that of a passenger come into contact with the track.
- \_\_\_ 8. Renter agrees to ride the snowmobile only on the marked and groomed trail system.
- \_\_\_ 9. Renter agrees not to allow any other person to operate the snowmobile during the rental period.
- \_\_\_ 10. Renter and any person riding on the snowmobile shall wear a helmet during operation.
- \_\_\_ 11. Renter agrees that he/she is not under the influence of alcohol or drugs and that he/she will not use alcohol or drugs during the snowmobile rental period.
- \_\_\_ 12. Renter understands that any damage to the snowmobile that requires replacement or repair (including labor) will be done at the renter's expense.
- \_\_\_ 13. Renter agrees that all replacement or repairs will be done by a dealer chosen by Recreational Springs Resort.
- \_\_\_ 14. Renter agrees to fill the snowmobile with the proper fuel as instructed by Recreational Springs Resort.

I have been introduced to the starting, stopping and safety features of the snowmobile. Snowmobiling is a potentially dangerous activity.

WARNING: If the vehicle is used, operated or driven in violation of any provision of this agreement, the snowmobile checklist, or damaged while unattended by the undersigned or additional driver (hit and run) or is damaged while striking a parked vehicle, stationary object, overhead object, etc. the undersigned renter and additional driver shall be liable for all loss, cost and damages as provided in this agreement by signature below the undersigned jointly and severally acknowledges that each has read and understood all the terms and conditions contained in this agreement and agree to be bound thereby. This is the entire agreement of the parties, and no rights of the lessor may be waived unless in writing and signed by a duly authorized officer or lessor. The undersigned renter further acknowledges receipt of a fully completed copy of this agreement and has neither received nor relied upon any statement or representation by the lessor or its employees which is not expressly stated in this agreement. Renter agrees that the fully understands how to operate the rented equipment.
